4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure – avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have a qualified person give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage. Seek medical advice.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical attention.

Eye contact: If in eyes wash affected eyes for at least 15 minutes under running water with eyelids held open. Seek medical attention.

Ingestion: Rinse mouth with water immediately. Give a glass of water to drink. Never give anything by mouth to an unconscious patient. If vomiting occurs give further water. Seek medical attention.

PPE for First Aiders: Wear gloves, apron, safety glasses, respirator. Use with adequate ventilation. If inhalation risk exists wear organic vapour/particulate respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Available information suggests that gloves made from nitrile should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

SMALL SPILLS

7. HANDLING AND STORAGE

Handling: Avoid skin and eye contact and inhalation of vapours mists or aerosols.

Storage: KEEP FROM FREEZING. Product stability may be affected. Store in original container in a cool, dry, well ventilated place, out of direct sunlight.
